RENTAL INCLUDES:

- 2 hours of pool time, Up to 25 guests (swimming or not), Use of Pool Locker Rooms, Lifeguard Coverage

ADDITIONAL GUESTS:

- Final guest count is DUE 7 days prior to your event. Not to exceed 120 guests. Final payment for any added guests is due at this time.
- Guest count over 25 guests will be charged an additional \$5 per guest.
- NO guests can be added within 4 days of your party due to Lifeguard staffing requirements.
- Pool can be reserved for one additional hour at an additional fee of \$100.00

PLEASE REVIEW AND INITIAL THE PARTY RENTAL RULES:

Initial _____ Lifeguards are required to call safety breaks every 50 minutes.

Initial _____ Swim test must be passed by each child to swim in the deeper end.

Initial _____ Non-swimmers must wear a wrist band (given after swim test) and their own Coast Guard approved life jacket (no puddle jumpers or arm floaties).

Initial _____ An adult must be within arms reach of each non-swimmer.

Initial _____ Adult guests MUST help supervise deck, pool activities, and direct traffic in the pool area.

Initial _____ All trash must be picked up and disposed of properly.

Initial _____ **NO ALCOHOL, VAPING OR TOBACCO PRODUCTS are permitted on YMCA property.**

Initial _____ Setup may begin 30 minutes prior to party. No one is allowed in the pool during this time.

Initial _____ Load out must be completed within 30 minutes of party ending. No decorations or personal items may be left on YMCA property.

Initial _____ No glass containers permitted anywhere in pool area.

Initial _____ Refunds will only be offered under the following circumstances: bad weather, 72 hour advance cancellation or circumstances out of our control.

- Guests must abide by the Barbara Bauer Briggs Family YMCA code of conduct.
- The YMCA has the right to cancel a party rental for misconduct.
